If they do, nominate Caritas Australia as your charity of choice and select your donation amount. Alternatively you can complete the form below.

- 2. Return your completed form to your Payroll office/Workplace Giving Coordinator.
- 3. Ask your workplace to contact Caritas Australia using our contact details on the form.

If you elect to receive correspondence from us about the impact of your support, you will also need to ensure your workplace passes on your details to us.
